

Exhibit 4.1 - Identification of Goods and/or Services for Bid

1. Detailed Instructions.

- 1.1. Bidder shall provide all information requested on “Section 2 - Detailed Information about the Goods and/or Services”.
 - 1.1.1. The answers provided are not binding on the Bidder. However, Bidder is expected to provide the most reasonably accurate answer to each item.
- 1.2. Bidder shall provide all information requested on columns C through E (Date of Availability, Labor per Unit, and Material per Unit) of Exhibit 4.2 - Identification of Goods and/or Services for Bid
- 1.3. Bidder’s prices for Goods shall include all costs related with their delivery to the following address:

1487 240th Avenue, Spirit Lake, IA 51360
- 1.4. Bidder’s prices for Services shall include all costs related with the following specifications:
 - 1.4.1. Fiber optic cable is to be laid or buried at 36" depth.
 - 1.4.2. At the end after installation the conduit shall be capped.
 - 1.4.3. Bidder shall install any pull tape necessary in the conduit or existing pipe.
 - 1.4.4. Bidder shall provide all duct plug and any additional pull cord.
 - 1.4.5. The plastic pipe size shall be indicated whenever directional and/or regular boring be used.
